STATEMENT OF ISSUE:

Public Works wishes to inactivate Fund 181 – Jefferson County Emergency Road Reserve Fund.

ANALYSIS:

The fund has had no revenue for the past many years other than investment interest earned. There is currently \$2,599.19 in the fund. Public Works would like these funds moved to Fund 180, County Roads.

The attached resolution directs the Jefferson County Auditor to inactivate the Jefferson County Emergency Road Reserve Fund, Fund 181 and further directs the Treasurer to move all funds in Fund 181 to Fund 180 upon inactivation. The Treasurer may deduct any investment management fees owing at the time of transfer.

FISCAL IMPACT:

This request has no fiscal impact, it simply moves funds from the inactivating fund to Fund 180 - County Roads.
