Resolution for final approval of Gustavsen Road vacation

Statement of Issue: The Board of County Commissioners adopted Resolution 13-23 on March 27, 2023 expressing an Intent to Vacate a portion of Gustavsen Road right-of-way, upon the Petitioner of the road vacation meeting certain conditions. The Board committed to adopting a resolution officially vacating the subject right-of-way upon verification by the Public Works Department that the conditions had been met.

Analysis/Strategic Goals/Pro's & Con's: The Public Works Department can now confirm that the Petitioner has complied with all of the required conditions, including execution of a Quit Claim Deed and a Restrictive Covenant, and that Petitioner has paid the County for the value of the vacated right-of-way and all other fees due.

Fiscal Impact/Cost Benefit Analysis: In accordance with JCC 12.10.120, the compensation paid by Petitioner, including \$20,000 for the value of the right-of-way, will be deposited into the county road fund.

Recommendation: The Board is requested to sign the attached Resolution and return to Public Works for further processing.
