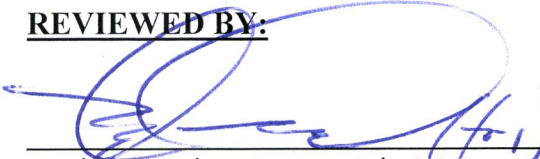
FISCAL IMPACT:

The fiscal impact of the County is \$7,185.65.

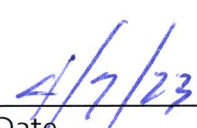
