WHEREAS, the registered nursing profession is a bedrock supporting health in Jefferson County through the Jefferson County Public Health Department, Jefferson Healthcare Hospital, local medical providers, and long-term care facilities; and,

WHEREAS, Jefferson County Public Health nurses are the first line of disease prevention and epidemiology working with local medical providers to assure testing and treatments for citizens with communicable diseases; and,

WHEREAS, throughout history, the nursing profession has played a major role in responding to crises and providing care and innovation that has saved lives and reduced suffering; and,

WHEREAS, from providing direct care to affected, hospitalized patients to leading full-scale public health operations, nurses are front and center working around the clock to protect the health and well-being of patients and the public at large; and,

WHEREAS, every year on May 6 we celebrate National Nurses Day; and,
