WHAT IS C-PACER?

Commercial Property Assessed Clean Energy + Resiliency (C-PACER)

1) Is it required?

This is a voluntary statewide program

2) What are the standards?

C-PACER program requirements are codified in RCW 36.165.

3) What projects are envisioned?

- a) Energy and water efficiency
- b) Electrification improvement (eliminates fossil fuel combustion),
- c) Renewable energy,
- d) Electric vehicle charging,
- e) Seismic hardening,
- f) Fire detection and suppression,
- g) Flood readiness,
- h) Stormwater management, and
- i) Energy storage among others

4) Why Adopt?

C-PACER implements important water and energy conservation goals; spurs rehabilitation and preservation; implement CAC goals.

5) Are there fiscal or capacity considerations?

Yes, and these have been addressed through third party administration.

6) Does the community support it? Yes, as evidenced by the CAC letter of support and public comment at prior BoCC meetings?
