STATEMENT OF ISSUE:

Public Health requests BoCC approval of a Public Hearing Notice to take comments regarding the three Conservation Futures Fund project applications submitted for consideration during the 2024 funding round. The notice is to be published on June 12th and June 19th in *The Leader*. The hearing is tentatively scheduled for Monday, June 24th at 9:45 a.m.

ANALYSIS:

Jefferson County Code (JCC) 3.08.030(4) requires a notice of public hearing prior to final action by the Board of County Commissioners on the annual allocations from the Conservation Futures Fund. Public comment on the Deerfoot Forest, Humbleberry Farm, and Tarboo Wildlife Preserve – West Slope Forest Addition projects will be accepted from June 12th, 2024 until the close of the Commissioners' hearing. After the public hearing, the BoCC may resolve to award funding to one or more of these projects.

FISCAL IMPACT:

Costs to publish the Public Hearing Notice in *The Leader* will be paid by the Conservation Futures Fund.

To facilitate a timely public process, Public Health recommends that the BoCC approve the Public Hearing Notice to hold the hearing on Monday, June 24, 2024 at 9:45 a.m.
