STATEMENT OF ISSUE:

Executive Director of the Jefferson County Historical Society (JCHS) Tara McCauley will provide the Commissioners with an update regarding the large-scale renovation project at the Museum of Art + History, one of three sites operated by JCHS. The renovation includes building modifications for ADA accessibility, new exhibits and exhibit infrastructure, and a new approach to annual county-wide research, collecting, and programs.

ANALYSIS:

The JCHS is reimagining the Museum of Art + History by transforming the space and visitor experience, with a focus on prioritizing the sharing of deeper, more diverse stories, enhancing accessibility, and integrating art and history.
