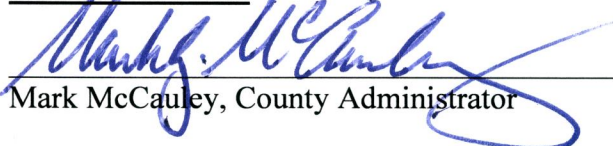
FISCAL IMPACT

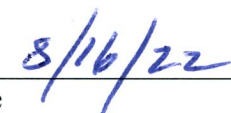
There is no fiscal impact as this is paid for by employees raising money, and County money does not contribute to these activities.
