MOTION TO AFFIRM re: 2024 Affordable Housing and Homeless

Housing Recommendations from the Housing Fund Board (HFB)

STATEMENT OF ISSUE:

On October 25, 2023 and November 29, 2023, the HFB members met to review RFP's received for 2024 Affordable and Homeless Housing projects in Jefferson County. There is \$965,000 available for Affordable Housing (Fund 148), and \$220,000 available for Homeless Housing (Fund 149). Applicants were told that their projects had to meet eligibility requirements under Senate Bill 5386, House Bill 1590 and RCW 82.14.530.

RFP Requirements 1.A.1 and 1.A.2 both delineate allowed uses according to RCW 82.14.530.

ANALYSIS:

The HFB members discussed which funds could be allocated for the proposed projects. After discussion, the Board passed a motion to recommend funding the following projects:
