ANALYSIS: For 2023, per RCW 84.56.240, the Treasurer is requesting authority to cancel personal property taxes levied against a Jefferson County business that has closed and departed the county: Reefer Den. Every effort has been made to collect these taxes. The Treasurer deems these taxes to be uncollectible.

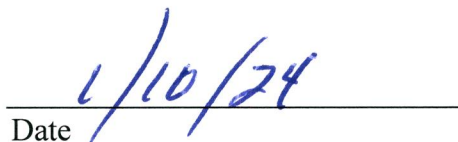
FISCAL IMPACT: The amount being requested for cancellation is \$101.98. The County Levies portion of that amount is \$12.33
