- 2. WW2 Sub-Chaser (110 ft) in the Columbia River near Longview, Cowlitz County WA.
- 3. 1944 Former Navy Seaplane Wrecking Derrick (101 ft) in the Snohomish River slough WA
- 4. 1944 Former US Army #7 Wooden Vessel (65 ft) in the Lewis River near the Columbia River, Woodland, Cowlitz County, WA

Formerly Federal Derelict Vessel Removal on Vulnerable Aquatic Lands advances priorities in NOAA's 2012-2025 Marine Debris Program Strategic Plan and the 2021 Washington Marine Debris Plan. This project also aligns with the 2022-2026 Puget Sound Partnership Action Agenda that targets DVRP efforts seek federal funding for derelict vessel removal.
