STATEMENT OF ISSUE: The Treasurer's office requests approval of a resolution canceling a total of 35 outstanding claims warrants and one (1) payroll warrants exceeding one year from date of issuance.

ANALYSIS: Warrants of any municipal corporation not presented within one year of issue shall be canceled by the passage of a resolution of the governing body per RCW 36.22.100. RCW 63.30.040 (10) and (11) list one year as the abandonment period for claims, wages and payroll checks. Previously public agencies followed a two-year abandonment period.

FISCAL IMPACT:

Upon cancelation of warrants, funds are credited to the issuing fund.
