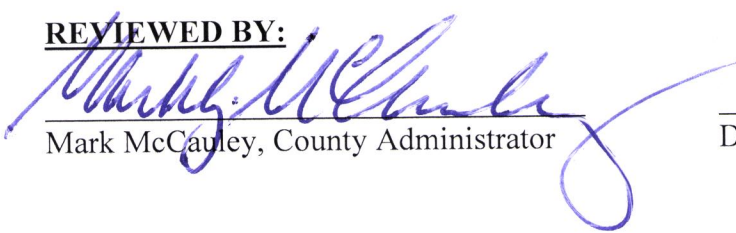
ANALYSIS:
