Statement of Issue:

The Jefferson County Department of Emergency Management consists of 3.4FTEs and numerous volunteers who are responsible for emergency management services for both Jefferson County and the City of Port Townsend. The Department is responsible for promoting disaster preparedness among the general public, maintaining operational readiness of the Emergency Operations Center, conducting disaster planning and risk assessment, and a number of other tasks related to disaster preparedness, response, recovery, and mitigation.

Analysis/Strategic Goals/Pro's & Con's:

The 2025 workplan currently drafted for the Department of EM staff consists a public outreach campaign featuring monthly training and information opportunities for the general public, drafting of several emergency plans, chief among them a Comprehensive Evacuation Plan, implementation of a new training and credentialing plan, ongoing development of our engagement of volunteer resources, and continuation of a number of ongoing activities related to preparedness and response. The Department would like to solicit feedback from the County Administrator and Board of County Commissioners and the draft workplan to ensure alignment with the County leadership's goals and vision.

Fiscal Impact/Cost Benefit Analysis:

The Department of Emergency Management has an annual budget of \$327,533.

Recommendation:

The Board of County Commissioners review and provide feedback on the Department of Emergency Management's 2025 workplan at the February 3rd meeting.




Incident Command System





Planning Projects



- Comprehensive Evacuation Plan
 - Identified as need during CWPP process
 - Evacuation plan will build on existing annex of CEMP to identify evac zones, routes, strategies, and key considerations
 - Will include exercises to improve/validate plan components, including a tabletop discussion and potential community evacuation drill
 - First meeting last week; plan completion by end of '25

Planning Projects



- Business Continuity Plan
 - Work originally planned for '26, with some pre-planning beginning this year
 - More info to follow, but DEM plans to start initial work shortly given current need
 - Will be a collaborative effort, led by DEM w/ support of HR, Central Services, with input from all departments

Planning Projects



- Emergency Support Function #11 Agriculture and Animals
 - Volunteer-led project to identify Jefferson County's food system resiliency and conduct outreach
 - Beginning development of "battle book" to identify food and ag resources for use in EOC activations
 - Food system and supply chain analysis
 - Additionally, work with NPREP groups and others to begin to identify animal evacuation and sheltering resources and needs
