Property for Kiosk

Statement of Issue: Public Works requests approval of the attached License to *Count Me In for Quilcene*, a nonprofit corporation, to use a portion of County-owned tax parcel #991-201-101. *Count Me In for Quilcene* intends to use a small portion of the County property (20'x35' License Area) to site a kiosk containing historical, cultural and environmental information along the *Quilcene History and Culture Trail*. The term of the License is from execution of the License until 60 days written termination notice issued by either party.

Analysis/Strategic Goals/Pro's & Con's: The License provides support to Count Me In for Quilcene to satisfy the terms of an AARP grant for the Quilcene History and Culture Trail. The County previously issued a letter of support for that project and this License further supports the project goals of community engagement and improvement of quality of life in the Quilcene community.

Fiscal Impact/Cost Benefit Analysis: The License does not require *Count Me In for Quilcene* to pay any compensation for use of the County property. The License requires the organization to indemnify and hold harmless the County for any claims, damage or injuries resulting from its use of the Property. The License also requires the organization to maintain the site and remove and restore the property upon termination of the License.

Recommendation: The Board is requested to sign the attached License and return it to Public Works for further processing.

GRANTOR, Jefferson County, a Washington municipal corporation, to promote community engagement and improve the quality of life in the community of Quilcene, and for no monetary consideration, does hereby grant and convey to GRANTEE, Count Me In for Quilcene, a Washington Nonprofit Corporation, a license over, across and upon the real property legally described as Lots 1 through 3, inclusive, Block 11 of the Original Townsite of Quilcene, as per plat recorded in Volume 2 of Plats on page 33, records of Jefferson County; situate in the County of Jefferson, State of Washington (the Property) and, in particular, the 20-foot by 35-foot area shown on Exhibit A attached hereto and by this reference made a part hereof (License Area); subject to the following terms and conditions:

- 1. <u>Use of License Area for Kiosk; No Representations or Warranties</u>. The License Area may be accessed and used by Grantee for siting and maintenance of a kiosk to highlight cultural, environmental and historical elements along the *Quilcene History and Culture Trail*. Grantor makes no representations or warranties as to the condition of the Property or its suitability for Grantee's permitted uses.
- 2. Grantee to Acquire Any Required Permits. Grant of this License does not satisfy or guarantee approval of any permits which may be required under Jefferson County Code. It is Grantee's responsibility to acquire all required permits for work on the Property.
- 3. Ownership of Kiosk; Removal at End of License Term. During the term of this License, Grantee shall retain ownership of the kiosk. Ownership shall not be transferred or assigned without the written permission of Grantor. At the end of the term of this License, Grantee shall remove all improvements installed by Grantee and shall repair any damage resulting from Grantee's use of the Property.

- 4. <u>No Dumping; Maintenance of the Property</u>. Grantee shall not deposit, or allow to be deposited, any waste material on the Property and shall be responsible for regular monitoring and maintenance of the License Area including, but not limited to, removal of all trash. Grantee shall immediately notify Grantor in the event of any vandalism of Grantee's improvements on the Property.
- 5. <u>Term of this License</u>. The term of this License commences upon execution of this License and terminates upon sixty (60) days written notice by either party.
- 6. <u>Shared Use of the Property</u>. During the License term, Grantee shall ensure that the Property (excluding the License Area) remain accessible for use by the Grantor for County purposes. With the exception of the License Area, the Property is not intended for use by the Public.
- 7. Indemnification. Grantee shall defend, indemnify and hold the County, its officers, officials, employees, agents and volunteers (and their marital communities) harmless from any claims, injuries, damages, losses or suits, including attorney's fees, arising out of or resulting from the acts, errors or omissions of the Grantee in performance of this Agreement, except for injuries and damages caused by the sole negligence of the County. Should a court of competent jurisdiction determine this Agreement is subject to RCW 4.24.115 if liability for damages occurs arising out of bodily injury to persons or damages to property caused by or resulting from the concurrent negligence of the Grantee and the County, its officers, officials, employees, agents and volunteers (and their marital communities) the Grantee's liability, including the duty and cost to defend, shall be only for the Grantee's negligence. It is further specifically understood that the indemnification provided constitutes the Grantee's waiver of immunity under Industrial Insurance, Title 51 RCW, solely for the purposes of this indemnification. This waiver has been mutually negotiated by the parties. This section shall survive the expiration or termination of this Agreement.
