STATEMENT OF ISSUE:

Anna McEnery, Jefferson County Public Health staff has requested that a renewal Letter of Assurance be considered for approval. This is so Jefferson County can continue to apply for the Accessible Community Advisory Committee, (ACAC) grant funding from the Governor's Committee on Disability Issues and Employment. Staff also requests approval of the ACAC membership list.

Since 2015/2016, Jefferson County has received \$206,311.05 in funding for ACAC grant projects that promotes awareness and acceptance of people who experience disabilities through education and access. ACAC projects have had a positive impact on people with mobility impairments, hearing loss, low vision and other access needs in Jefferson County. We have completed projects in Port Townsend, Tri-Area, Coyle, Quilcene, and Brinnon.
