Membership of the Marine Resource Committee:

There shall be thirteen (13) voting members and three (3) nonvoting members of the Jefferson County MRC, appointed by the Board of County Commissioners, to ensure that the membership of the committee is balanced and representative.

The voting members shall be:

- One member representing Commercial Interests
- One member representing Environmental or Conservation Interests
- One member representing Recreation Interests
- One member representing Marine Science Practitioners, Educators or Researchers
- One member representing Tribes
- One member representing City of Port Townsend
- Six members representing Citizens (2 representatives from each Commissioner District)
- One member representing Local Youth (starting age of 15-21 years old)

The nonvoting members shall be:

- One member of the Board of County Commissioners
- One member representing the U.S. Navy
- One member representing Port of Port Townsend

The Local Youth representative shall serve up to a four-year term. All other members shall serve staggered, four-year terms. The MRC chair shall be selected by a majority of the MRC membership. MRC members shall also select a representative to the Northwest Straits Commission by a majority vote.
